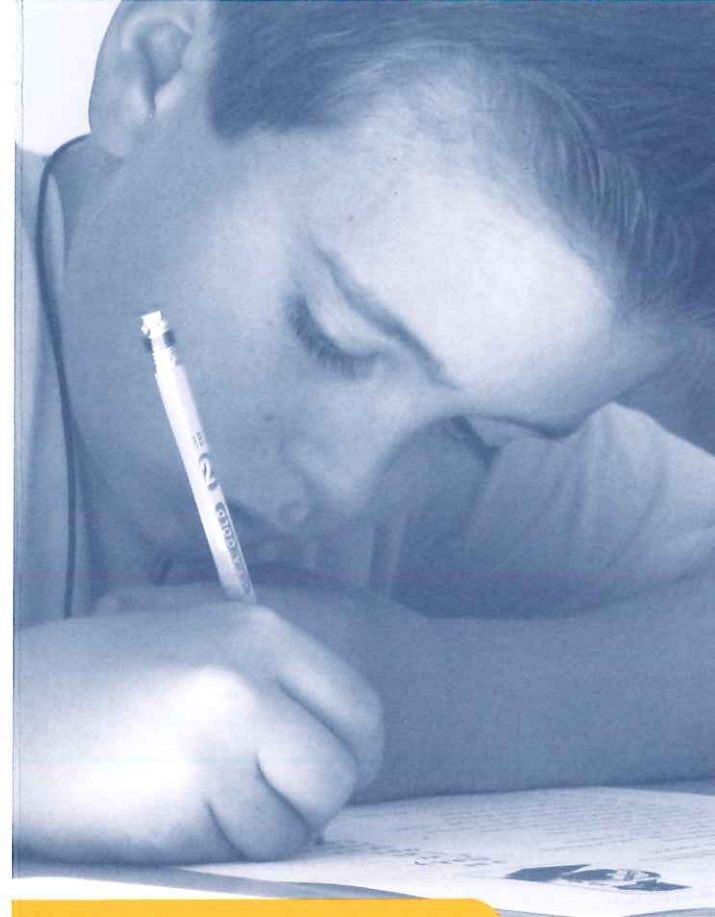

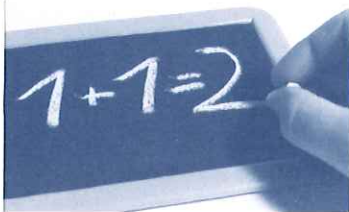
Why Get On Board?

The Board of Directors has established an Endowment Fund that will facilitate the advancement of the goals and objectives of the Christian School for this and future generations. The primary beneficiaries of the income from this fund will be the families who meet the requirements of the Tuition Grant Policy, thereby providing tuition assistance to those families who otherwise would not be able to enjoy the benefits of a God-centered education for their children.

The Board works diligently to provide a faculty and curriculum for the least expense possible, but understands that there are many families who need some assistance in meeting tuition requirements. We are committed to keeping the school doors open to as many families as possible, and your contribution to the Endowment Fund is essential for the long-term health and growth of our community's children.

A complete copy of the Investment Policy is available upon request at the school office. The Endowment Fund is owned and administered by the Christian School of Grace Baptist Church and is supervised by an Investment Subcommittee (IS). The IS hires and supervises a professional investment manager to invest the funds in accordance with very specific guidelines as described in the Investment Policy. All contributions are tax deductible as a charitable contribution. The plan specifies investment goals and maximum annual distributions.



Doing the Math.

The immediate goal is to raise a fund with a minimum principle balance of \$1,000,000.

The income from this fund primarily will meet the needs of our Tuition Grants Program. Additional consideration for subsidizing the development of new curriculum, technology, and continuing education for teachers will be made as additional funds are available.

How Can You Change a Life?
